Streamlined inspection and audit process

The Liberian Registry offers shipowners and ship managers a combined block fee agreement (C-BFA), which covers verification and certification for compliance with the Maritime Labour Convention 2006 (MLC), International Safety Management (ISM), and International Ship and Port Facility Security (ISPS) audits.

The MLC, ISM, ISPS and the Annual Safety Inspection (ASI) requirements partly overlap, so reviews can be combined and conducted during a single ship visit by our specially trained auditors and inspectors. Liberia's harmonization initiative helps save time, money, and personnel resources.

Combined Block Fee Agreement

Services Covered by C-BFA

The C-BFA is a 5-year agreement that includes the following during the first 5-year cycle:

- Issuance of Declaration of Maritime Labour Compliance (DMLC) Part I
- Review and acceptance of DMLC Part II
- Initial and Intermediate Inspection for a Maritime Labour Certificate
- Intermediate Inspection for certification with MLC 2006
- Unlimited amendments to the DMLC Part I, DMLC Part II, and Maritime Labour Certificate
- Initial and Intermediate Audit for an International Ship Security Certificate (ISSC)
- Unlimited amendments to the ISSC Certificate
- Initial and Intermediate Audit for a Safety Management Certificate (SMC)
- Unlimited amendments to the SMC Certificate

Associate Services and Fees

The Liberian Registry also offers the following additional services at discounted rates for vessels included in a C-BFA:

- Interim ISM/ISPS/MLC audit and inspection
- Company Document of Compliance audits
- Shipboard plan review
- Additional MLC inspection or ISM/ISPS audit
- Ship Security Alert System initial or replacement installation verification

- Renewal and Intermediate Inspections for MLC 2006
- Unlimited amendments to the DMLC Part I, DMLC Part II, and Maritime Labour Certificate
