Subject: Security Level in the Libyan Port of Tobruk

### **Dear Shipowner/Operator/Master:**

As per the attached IMO circular letter No. 4802, the Libyan Ports & Maritime Transport Authority has informed the IMO that the Security Level in the port of Tobruk has been increased to Security level 2 in accordance with the implementation of the ISPS code.

As per the circular letter No.4802, ALL Liberian registered vessels calling in the Libyan Port of **Tobruk** shall raise security level to 2 and implement specific protective measures in the ship security plan and acknowledge receipt of the instruction on change of security level.

**Reminder:** No Liberian registered vessel shall operate at a Security Level lower than that of a port facility. Additionally, the Master has the Overriding Authority to increase the security measures of the vessel at anytime to protect the safety and Security of the vessel.
